**Non-Refundable Registration Fee (Elementary, Primary and Pre-Primary Montessori):**

- New student: \$160
- Current student: \$120

**Non-Refundable Materials Fee:**

- Elementary: \$285 (Includes Standardized Testing Fees)
- Primary and Pre-Primary: \$100 \_\_\_\_\_ (initial)

**Tuition Discounts:**

- Sibling Discount: 5% off tuition. The child (or children, if more than two) with lower tuition receives this discount.
- Military & Law Enforcement Discount: 5% off tuition on all children. Proof of active duty required.
- Pastor's Discount: A letter from the Parent's employer confirming engagement in full-time (35 hrs min/wk) ministry is required. Single child or child with higher tuition rate: 25% discount on tuition. All other children will receive a 50% discount on tuition.

Tuition Discounts are not applicable to late pick-up fees, extended hours, Day ("drop-in") rate, enrichment classes, or any other school fees.

**\* Discounts apply to tuition only. Families may apply one discount per child per school year. Discounts cannot be combined.**

**Tuition Policy for All Programs**

Annual tuition is based on the 10-month academic year. Tuition may be paid in full at the time of registration, or in ten payments.

**Registration fee, materials fee, and tuition deposit (one payment applied to the last four weeks of tuition of the academic year; in most years, this will be the last two weeks of May and the first two weeks of June), are due upon confirmation of enrollment. These fees are not refundable, nor can they be applied to other charges, including tuition, if withdrawing from school.** \_\_\_\_\_ (initial)

Thereafter, payments will be due on the first day of each month (September through May), regardless of the student's schedule.

**Tuition is not subject to refund, adjustment or credit for any student absence due to illness, holidays, non-school days, vacation, or any school closures for reasons such as, but not limited to health and safety concerns, fire, earthquake, flooding, terrorism, or pandemic. We do not offer make-up days for days missed in absence.** \_\_\_\_\_ (Initial)

A \$15 late payment fee will be charged after the fifth day of each month for which tuition is not received and will continue to be assessed every five calendar days thereafter.

A \$30 fee will be charged for each check returned by the bank.

A 30-day written notice is required for any schedule changes or withdrawals. \_\_\_\_\_ (initial)  
At its discretion, Legacy Montessori School reserves the right to terminate a student's enrollment for reasons of non-cooperation, non-payment of fees, or inability of student or parents to adjust to the school's programs or policies. California Community Care Licensing has the authority to inspect the facility, review records and interview students without parent's consent.

## **Disaster and Pandemic Release of Liability Agreement**

### **Agreement, Release, and Indemnification of All Claims, and Assumption of Risks for Natural or Man-Made Disasters, Pandemic/Infectious Diseases**

Cornerstone Christian Montessori School, DBA Legacy Montessori School (henceforth designated as LMS) and the undersigned, acknowledge the risks for natural or man-made disasters, pandemic/infectious diseases such as, but not limited to fire, earthquake, terrorism, Coronavirus/COVID-19, Monkeypox, etc. We are all in this together and we appreciate your commitment to your health and that of the community.

#### **Participating Family Commitment**

As a participant in Legacy Montessori School's Program, I/we commit to the following safety measures, while inside and outside of the Program's schedule:

- Respect and practice health and social distancing guidelines issued by Federal, State and local authorities.
- Maintain transparency and honesty about your exposure to risks. Report immediately any sickness or exposure to it.
- Abide by Legacy's Health and Safety Procedures.

#### **Pandemic/Infectious Disease Disclaimer & Acknowledgment of Risk**

Pandemic/Infectious diseases such as, but not limited to, Coronavirus/COVID-19 or Monkeypox, are contagious diseases that spread easily through person-to-person contact. LMS in no way warrants that diseases/infection will not occur through participation in our Program. I/we hereby acknowledge and agree that participating in LMS's program comes with this inherent risk.

#### **Waiver, Release, Indemnification, & Covenant Not to Sue**

I/we hereby certify that I/we have full knowledge of the nature and extent of the risks inherent in participation in the Program and that I/we and the Minor(s) are VOLUNTARILY ASSUMING SAID RISKS and that by signing this Agreement, I/we and the Minor(s) HEREBY RELEASE LMS of all liability.

**In consideration of being allowed to participate in the Program, I/we and the Minor(s) on behalf of ourselves and our respective heirs, representatives, executors, administrators, and assigns, agree and HEREBY DO RELEASE LMS and its owners, respective officers, directors, members, employees, volunteers, agents, representatives, and insurers (“Releases”) from any causes of action, claims, or demands of any nature whatsoever.**

By signing this Agreement, I/we give up our right and any named minor’s right to bring a court action to recover compensation or obtain any other remedy for any risk or exposure to disasters, Coronavirus/COVID-19, or other infectious diseases, however caused, arising out of your and/or any named minor’s participation at LMS now, or any time in the future.

This Agreement is signed by the undersigned in his/her/their individual capacity as well as in the undersigned’s legal capacity as the lawful custodial parent or legal guardian on behalf of any minor(s) whose name(s) are written below (“Minor(s)”).

I/we further certify that I/we understand that due to the risks and uncertainties of a natural or man-made disaster or a Pandemic/Infectious Diseases, that some parts or all of the Program may be canceled, postponed, or otherwise altered due to the threat of injury, infection or actual infection, other causes, or governmental laws, regulations, or orders.

I/we also understand that if the Program must close for any of the above-mentioned reasons, all fees and payments are non-refundable.
